As already been intimated to you that CIRP has been initiated in respect of your company M/s THRIVE SOLAR ENERGY PRIVATE LIMITED under the Provisions of Insolvency and Bankruptcy code 2016, by an order of NCLT-HYDERABAD CP(IB) No.355/9/HDB/2018 Dated 31/10/2018.

Please be informed that I have been appointed as the Resolution Professional at the meeting of the Committee of the Creditors held on 30<sup>th</sup> November 2018 and confirmed by NCLT Hyderabad vide its order dated 24-12-2018 in IA No. 707/2018 in CP (IB) No. 355/9/HDB/2018. A copy of the order is enclosed for your reference. I have taken the charge from today onwards to act as Resolution Professional.

It may further be noted that in consonance with the stipulation contained in section 14 of the code, Amortatorium has been declared vide the aforesaid order passed by NCLT, where by interalia, the following shall be prohibited:

- (a) the institution of suits or continuation of pending suits or proceedings against the corporate debtor including execution of any judgment, decree or order in any court of law, tribunal, arbitration panel or other authority;
- (b) transferring, encumbering, alienating or disposing of by the corporate debtor any of its assets or any legal right or beneficial interest therein;
- (c) any action to foreclose, recover or enforce any security interest created by the corporate debtor in respect of its property including any action under the Securitization and Reconstruction of Financial Assets and Enforcement of Security Interest Act, 2002;
- (d) the recovery of any property by an owner or lessor where such property is occupied by or in the possession of the corporate debtor.

The instant intimation w.r.t intimation of CIRP and appointment of RP is for your information and record. I shall keep the statutory Authority posted on further developments in this regard.


